 - i. Multi-year project
 - ii. Village paid over \$500K to dredge ponds
 - iii. Grant approved and funded for \$39K (reimbursed for ~50% of total project costs). Grant was approved for more than asked for.
 - iv. Work already complete for erosion prevention with Aldridge
 - v. Village paid for rip-rap in the dogbone channel. MCAA owed 50% of the cost to Village but will likely pay back by doing other pond work (i.e., aerators).
 - vi. Awarded additional work to Pond work to Encap and notified two other vendors. Village engineer approved of MCAA plan.
 - vii. Special pond meeting will be scheduled to go over detailed plans with Encap
 - viii. Some work will be completed this year, plantings in the fall and additional work will continue into Spring 2024. Maintenance through 2025.
